## **SOPGA Hall of Fame Candidate Evaluation Chart**



## **Purpose**

To assist the SOPGA Hall of Fame Committee with identifying the most deserving candidates for the SOPGA Hall of Fame in the most objective, unbiased, and qualitative way possible.

# Description

The SOPGA Hall of Fame Candidate Evaluation Chart was developed to assist current and future Hall of Fame Committee Members assess candidates under consideration for entry into the Hall. The chart simply places a numerical value on individual accomplishments, achievements, and contributions to the game of golf.

#### **Process**

- 1. The Hall of Fame Chairman and the Section Executive Director will independently assign numerical values to each candidate's responses to the candidate questionnaire.
- 2. The Chairman and ED will meet to review each candidate's rating and settle any differences.
- 3. Staff will distribute the final chart values with candidate questionnaires and ballots to the entire Committee, prior to the Candidate Review meeting.
- 4. Note, the areas in which candidates can earn credits shall always coincide with the questions and categories detailed on the Hall of Fame Candidate Questionnaire, which are currently defined as: Service, Playing, Mentorship, Award/Honors, Teaching, and Miscellaneous.
- 5. Candidate's credits are added together, giving the candidate an overall rating.

Co-founder and Co-Chairman of the Mike Zimmerman **G**ift **O**f **L**ife **F**undraiser Charity Pro-Am 1988 – 2005. We raised awareness of and money for organ donations and transplant recipients.

- **4.** Please list the most successful programs you initiated to promote the game of golf:
  - Spring Training at Miami Valley Golf Club: I was available March May from 4:00 pm until dusk, Tuesday (full swing) and Thursday (short game) for free coaching and check-ups for anyone that came out. I worked with a majority of the membership and attracted some new members.

- Annual Masters Celebration: This program brought members to the club Wednesday Sunday.
  There was an auction of the tournament players on Wednesday evening. Members could
  practice, play and compete in various contests Thursday Sunday. Many participants
  remained at the club to watch TV coverage, take advantage of various food and beverage
  specials and collect their winnings from the auction.
- Established a per hole golf cart fee: There are several 2, 3, and 6 hole loops to play at MVGC. After a lesson I suggested that my student try what they learned on the golf course. We also promoted play as many holes as you can between work and dark.
- Planned events associated with historical dates at MVGC, explained later in #6.
- **5.** Please give a synopsis of your competitive playing record and include scores:
  - 2004 SOPGA Section Senior Champion score 143
  - Participated in 3 National CPC events and 1 National Senior CPC event
  - Qualified for 2 Nike Tour events held in Dayton
  - Miami Valley/Dayton Chapter Player of the Year 3 times
  - Lowest competitive round 65
- **6.** Please list your favorite aspect of the business and why you feel this way:

Because I believe that remembering the past should help to make the future better, I enjoyed promoting the history of the game and recognizing the people that had an influence. In my early years at MVGC I met a club member, Robert Kuntz. He was a historian and at the time a member of the USGA Museum Committee. He shared his knowledge and many stories as we organized several events at MVGC.

- Contests and tournaments where participants used hickory shafted golf clubs
- Exhibits of golf history in Dayton
- During the MVGC 75<sup>th</sup> Anniversary Celebration in 1994 we focused on 3 events.
  - The 1957 PGA Championship was the last contested using the match play format. There is a plaque at #17 tee commemorating where that last match finished. One of the most memorable and enjoyable rounds of golf for me was during an exhibition where I had the honor and pleasure of hosting the 1957 PGA Championship finalists, Lionel Hebert and Dow Finsterwald. I got to walk, talk and play 16 holes with those 2 PGA Champions.
  - We also organized an 18-hole relay event for past and present members of MVGC. The goal was to have players hit one shot each in an attempt to shoot 75 in 75 minutes; we had over 90 people participate while completing the round in less than 70 minutes. There were several great stories told and created that afternoon.
  - o Bob Serves, a past member of MVGC, is the only 5 time Ohio Amateur Champion. There is a plaque at #1 tee so that he will be remembered and to inspire future players at MVGC.
- Robert Kuntz served as the Honorary Starter at the 2004 SOPGA Section Senior Championship and was recognized for his service to the game with the SOPGA Lifetime Achievement Award.
- 7. Please tell us about your most memorable moment in the golf business:
  It has lasted much longer than a moment. In 1977 I caddied for Debbie Austin on the LPGA Tour.
  While in Plymouth, IN., at The Hoosier Classic, during the Saturday round, Debbie played herself into

contention and I introduced myself to a spectator in her gallery. History shows that Debbie Austin won the tournament and that spectator has been my wife for 38 years.

Ray Rash is the complete Golf Professional. He is the possessor of exceptional skills and talent in all phases of our profession. This came to be through planning, training, hard work, and perseverance.

Ray is without peer in creating a great fun golf atmosphere. This is a relaxed, warm, welcoming environment throughout all levels of golf club life. The men's, women's, couples, and junior programs are always fun and interesting with great participation and spirit.

Ray's merchandising of his golf operation is a true model of success. It is built on the premise of learning, knowing, and catering to the levels and tastes of his clientele. Ray's inventory is always fresh and moving through managing spaced arrival and price control dates. Private showings and viewing of high-end lines by sales reps leads to a certain " pre-sold volume. Ray's capable golf staff is always trained and aware of the service level required. If everyone followed Ray's formula; golf shops would be more successful, and big box stores much less so! Ray was recognized by SOPGA as its Merchandiser Of The Year - Private in 1988.

Ray developed a strong interest in golf club design and repair early in his golf experience. He went to work for Wiley Watkins at The Carolina Club Shop in Charlotte. Through this experience, Ray became skilled and adept at most repair and club building steps and techniques. This planted the seeds for his later interest and success in club fitting and design. Ray was selected to be one of the first to offer The Slazenger Club Fitting System. He was also one of the first to do lazer putter fitting; offering Kirk Kourie putter designs.

Ray has always been an excellent player. He was an active competitor in Section and Miami Valley Chapter events. He qualified for both The National Club Professional Championship and The Senior Club Professional Championship. He was Medalist in the US Open local qualifier at Kenwood Country Club. He won the Miami Valley Open and the Miami Valley Match Play. He won many Miami Valley Pro-Ams and Pro-Pros. He was a regular competitor in the Ohio Open the Piqua Open, the Middletown Open, in the Wright Pat Open, In the SOPGA Championship and SOPGA Senior Championship. He had several high finishes in the Springfield Open.

Ray volunteered his time and efforts to both the SOPGA and to the Miami Valley Chapter. In both he was active in education and tournaments. Ray is an accomplished calligrapher. His skills enhanced his professionalism both in his club operations and in his volunteer work . Ray was recognized by SOPGA as its Horton Smith Award winner in 1996.

Ray has a keen interest in history; especially golf history. It was altogether fitting and proper that he would represent Historic Miami Valley Golf Club as their Head Golf Professional. Ray was instrumental in the celebration of many of the great events and traditions of the club. He spearheaded the celebration of the career playing accomplishments of club employee Bob Servais with an annual member tournament and dinner. He started a "Hickory Shaft and period dress" annual event to honor Donald Ross,

Miami Valley Golf Club, and club member Bob Kuntz, founder of "The American Golf Club Collectors Society" He conceived and hosted a celebration of the 1957 PGA Championship held at Miami Valley Golf Club.. This was the last PGA contested at match play. The final match was Lionel Hebert vs Dow Finsterwald. Both participants returned for and played in the celebratory event.

The SOPGA recognized Ray Rash as their Golf Professional Of The Year in 1994. Ray worked for Hall of Fame Member Jimmy Gilbert at Dayton Country Club. Ray worked for and with Hall of Fame Member Jeff Steinberg at NCR Country Club and at Miami Valley Golf Club.
